Assessment and Care Planning

The Braden Scale II[®] is the most widely used pressure injury risk scale used today.

Barbara Braden teaches us that “each subscale score serves as an initial appraisal of a patient’s specific problems and functional deficits, a flag for assessments that need to be explored further, and a guide to the types of interventions that may be required.”

With Braden Hester PIP, the pressure injury risk factors are mapped to specific interventions in the Braden Hester PIP Care Plan[®] creating efficiency and ability to measure effectiveness of the interventions.

Pressure Injuries Today

According to AHRQ

Pressure injuries increased 6% from 2014-2017

2.5 million hospital acquired pressure injuries (HAPI) occur annually in the US

Cost to treat a HAPI ranges from \$500 to \$70,000

60,000 deaths are reported annually related to HAPI

HD Nursing Intelligence is our portal designed to help you “*Make Sense of Your Data*”.


The program compliance data you submit is securely stored and analyzed within the portal, providing you with the data you need to drive decisions and communicate the status of your patient safety program.

The audit information will help you track your organization’s current and historical performance and boost efficiency efforts by directing your team to incorporate education tools that target opportunities for improvement as identified in the audits and post-fall huddles.
